**To Enter Online:** Beginning 12:00:00 a.m. ET on the Start Date of each applicable Entry Period, access [www.makershourquiz.com](http://www.makershourquiz.com), complete all required information on the Sweepstakes entry page including answering three questions for our Cocktail Quiz (the "Quiz"), and follow the on-screen instructions to submit your Entry. Entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry.
